CASE MANAGEMENT ORDER No. 32

IT IS HEREBY ORDERED that the monthly status conference set for **November 3, 2011**, is **CANCELED**.

IT IS FURTHER ORDERED that the following telephone status conferences and final pretrial hearings will be held:

1. **Thursday, December 8, 2011 at 12:30 p.m.** Telephone status conference only.
2. **Thursday, March 15, 2012 at 10:00 a.m.** Status conference for all cases followed by final pretrial hearing for *Gulf Pacific Rice Co., Inc., et al. v. Bayer CropScience LP, et al*, 4:08CV1545 CDP, which is set for trial on March 19, 2012. **In Courtroom.**
3. **Thursday, May 3, 2012 at 10:00 a.m.** Status conference for all cases followed by final pretrial hearing for *Beaumont Rice Mills, Inc., et al. v. Bayer CropScience LP, et al*, 4:07CV524 CDP, which is set for trial on May 7, 2012. **In Courtroom.**
4. **Thursday, July 5, 2012 at 10:00 a.m.** Status conference for all cases

followed by final pretrial hearing for *Kennedy Rice Dryers, LLC v. Bayer CropScience LP, et al.*, 4:07CV1773 CDP, and *Planters Rice Mill, LLC v. Bayer CropScience LP, et al.*, 4:07CV1795 CDP, which are set for a joint trial on July 9, 2012. **In Courtroom.**

5. **Thursday, September 6, 2012 at 10:00 a.m.** Status conference for all cases followed by final pretrial hearing for *Texana Rice Mill, Ltd., et al. v. Bayer CropScience LP, et al.*, 4:07CV416 CDP, which is set for trial on September 10, 2012. **In Courtroom.**


6. **Thursday, November 29, 2012 at 12:30 p.m.** Telephone status conference only.

7. **Thursday, February 28, 2013 at 10:00 a.m.** Status conference for all cases followed by final pretrial hearing for *Phoenix Advisors, Ltd. v. Bayer CropScience LP, et al.*, 4:08CV1794 CDP, which is set for trial on March 4, 2013. **In Courtroom.**

For status conferences that are not combined with a final pretrial conference, plaintiffs' lead counsel will place the call and make arrangements for having all counsel who wish to participate on the line. All calls will be on the record. One week in advance of each status conference, lead counsel shall file a joint status report setting out the current status of the work and any topics they wish to address during the conferences.

For status conferences that are combined with final pretrial conferences in the courtroom, although lead counsel and at least one trial counsel for each side must be present in person, other counsel may participate by telephone. The Court will arrange the call and provide a call-in number. The status conference will be held at the beginning of the hearing, with final pretrial issues to be discussed after status issues.

IT IS FURTHER ORDERED that, for each of the above cases set for trial, the attorneys shall file their initial pretrial submissions, including a joint statement of the case, proposed witness lists, exhibit lists, proposed jury instructions, deposition designations, and motions in limine, **not less than twenty (20) days before to the date set for trial**. Final pretrial submissions, including responses to motions in limine, objections to exhibits, counter-designations to the depositions, and objections to jury instructions, shall be filed **not less than ten (10) days before to the date set for trial**.
