NOTICE OF FILING OF LIST OF PENDING RELATED CASES

Attached as Exhibit A is a list of pending related cases known to lead counsel as of March 15, 2010, with the information requested in CMO 5 and discussed at the March 11, 2010, status conference.

Exhibit A provides summary information in a table. The cases are ordered by jurisdiction (federal, then state), and then by state. Only those federal cases which have not yet been finally transferred to the Eastern District of Missouri are included. The column “Date Filed” indicates the date the complaint was filed.¹ The column “Plaintiffs Attorney Group” reflects lead counsel’s current best estimate of which attorney group filed the complaint. The column “Before JPML” reflects whether a Notice of Tag-Along Action has been filed with the Judicial Panel on Multidistrict Litigation (“JPML”) and, if filed by Bayer CropScience LP, the date of such filing. The column “JPML Transfer Order” indicates whether the JPML has issued a Conditional Transfer Order covering the case and, if so, the initial date of such order.

Nine Arkansas state court actions have had trial dates set or adjusted. In *Schafer, et al. v. Bayer CropScience LP, et al.*, Arkansas State Court, Lonoke County, Case No. 2006-413, trial begins on March 22, 2010. Judge Philip Whiteaker is presiding and his phone number is (501) 676-3007. In Desha County, Arkansas, the Honorable Bynum Gibson has set six cases for trial on July 19, 2010, with the expectation that at least one case will be tried in the two weeks set

aside for trial. Judge Gibson's phone number is (870) 367-7604. *Schwartz v. Bayer CropScience LP, et al.*, Arkansas State Court, Desha County, Case No. 2009-119, is the first case set to proceed on July 19. In *Briggs, et al. v. Bayer CropScience LP, et al.*, Arkansas State Court, Jefferson County, Case No. 2009-173-5, a three week trial is set for September 20, 2010. Judge Jodi Raines Dennis is presiding and her phone number is (870) 541-5377. No other state court actions have trial dates set.
